

SENNERUPPU IDEATIONS

From Day to Week



Phoenix-the Next Generation remains committed to upholding the core values of the Tamils' struggle for liberation. As such, commemoration and political spaces continue to be diluted over the years - the most significant of such being the month of May which is used to commemorate the peak of Tamil genocide which was orchestrated in Mullivaikkal by not only the genocidal Sri Lankan state but various global superpowers.

Frustrated by over a decade of self-victimised perspectives within our community, we as Phoenix decided to encapsulate our wider community into our strengthened views of commitment, loyalty and courage through introducing them to the concepts of the Nandhikadal Principles which emerged on those very shores in 2009.

When all the oppressing powers unite to destroy an oppressed nation, the stand that the oppressed nation takes at this moment is representative to all oppressed people.

Thus, it is on this basis of addressing international complicity and international solidarity that our Australia Division spearheaded our engagement in Senneruppu activities from 2021, declaring 18.05.2022 as "Senneruppu Naal" or "The Day of Red Fire."

With a presence in over 7 countries and 3 continents, the opportunity to maximise mobilisation and exposure was used in 2022 where Senneruppu Naal was expanded to "Senneruppu Vaaram" or "Senneruppu Week" between 11.05.2022-19.05.2022. This year's projects were thus conceptualised through the categorisation of Tamil genocidal ideology into core areas and thus split amongst five countries for activities to be conducted in their respective domains. All activities reached a pinnacle on 18.05.2022.

DAY 1: SINHALICISATION - DENMARK

A social media campaign on the role of Sinhalicisation in fostering ongoing Tamil genocide was examined by our newly formed Denmark team. It is notable that this was the team's first project.

DAY 2: ENFORCED DISAPPEARANCES - SWITZERLAND

The Swiss team examined how enforced disappearances facilitated subsequent Governments of Sri Lanka attempted to further Tamil genocide and deprive Tamils' of their future leadership through activities conducted on Days 2 and 4. Day 2 was used as

an opportunity to engage youth across social media through a social media campaign which examined the profiles of 14 individuals who were forcibly disappeared by the Sri Lankan state with the above-mentioned intent.

DAY 3: INTERNATIONAL COMPLICITY - UK

Phoenix TNG's UK team also engaged in their first official project through Senneruppu Vaaram. With Phoenix TNG-UK representation scheduled for the third phase of the Permanent People's Tribunal (PPT) on Sri Lanka in Berlin between 19.05.2022-22.05.2022, the team decided to generate content regarding international complicity and Tamil genocide using material gained from the first two phases of the PPT. The content was then shared on social media platforms.

DAY 4: ENFORCED DISAPPEARANCES - SWITZERLAND

Day 4 marked the launch of a virtual exhibition gallery which featured the 14 profiles and supplementary material within a virtual space. Further, a Karthiaai Poo Seed Distribution Drive was also facilitated by Phoenix TNG-Swiss members at Tamilskalary in Bern, Switzerland which gained mass support and engagement from the public. As the seeds will bloom with our national flowers across households in Switzerland, so too will mass courage and commitment to our unwavering struggle.

DAY 5: MILITARISATION -AUSTRALIA (SYDNEY)

The Australia Division of Phoenix TNG conducted



activities exposing the role of militarisation in facilitating ongoing structural Tamil Genocide and its subsidiary components across Days 5 and 6 of Senneruppu Vaaram. Day 5 saw an announcement made by the Sydney branch of Phoenix TNG-AU declaring that a Karthigai Poo Plantation Drive would be conducted at the local

Tamil Memorial Monument during an appropriate season. Similar to the Swiss team, the announcement comes as an announcement to strengthen existing spaces in declaring voices of Tamil resistance in an unwavering manner.

DAY 6: MILITARISATION - AUSTRALIA (MELBOURNE)

The Melbourne branch of Phoenix TNG-AU conducted a Webinar on Militarisation as a cornerstone in Tamil genocidal ideology which facilitates components of genocidal ideology to be propelled. The demographic shifts and impending geographic tactics examined invigorated the participants to be proactive in shifting such attempts.

DAY 7: SCREENING - CANADA

The Canada Division of Phoenix TNG conducted a small-scale screening of our original mini documentary, "Beyond the Red" at a library in Brampton. It must be noted that it was decided by the attending youth that such screenings should be conducted on a larger scale to engage wider audiences and educate them on the sheer scale of international complicity in Tamil Genocide.

DAY 8: SENNERUPPU NAAL

Whilst Senneruppu Naal was marked by Phoenix members across the countries that we reside and operate in through active participation and engagement in locally organised commemorative events, two seminal activities across opposite ends of the globe reiterate the values and commitment of Phoenix.

Karthigai Poo Plantation - Switzerland



Phoenix members who had visited the Tamil memorial stone situated in Yverdonles-Bains earlier on 15.05.2022, cleaned the site which had been in disarray.

They later returned on 18.05.2022 to conduct a Karthigai Poo Plantation Event.



The neglected pots and stone were cleaned once again, refilled with fresh soil and replanted with sustainable plants. Further, karthigai poo seeds were planted by each member. Following this a small vigil was held at the site with an ahavanakkam and lighting of eehaichudars.

This act not only reflects the strength of commemoration, but the stance we have assumed as Phoenix. If a fault is sited within our collective struggle, it is not our duty to point fingers, laugh and proceed with an elitist mindset. This struggle is for our collective liberation and thus we have a responsibility for both its successes and failures. As Phoenix, our initiative to rectify the mistakes sighted at this memorial site and elevate it to the next stage is a symbolic indicator of our commitment to our responsibilities.

Member Induction - Melbourne, Australia

In addition to Phoenix TNG's activities, our members are known for our strict discipline which is embodied through our uniform. Each Phoenix member is presented with a member chain which has the head of a tiger emblazoned on it. This chain is symbolic of each member's commitment to our people, our struggle and our organisation. It is a reminder that we are all connected to each other despite geographical differences, and it embodies the sacrifices of not only thousands of our maaveerar and brethren but also our fellow comrades who stand by our sides, shoulder to shoulder as we carry forward



responsibility for our struggle for liberation.

In that regard, a
Phoenix Member
Induction ceremony
was conducted on a
small-scale in
Melbourne at a local
Tamil Genocide
commemoration event.
This induction saw that
each member had their
chain placed around
their necks by their
local coordinator - with
whom they will lead
their local activities.

It is notable that such an induction was conducted for the first time on Senneruppu Naal.

Horizons

The development of Senneruppu activities from a day to a week is not a mere extension of activities but rather an expansion of Phoenix's horizons. A new generation of invigorated Phoenix members are being developed as unwavering and unforgiving young leaders. The speed of these leaders combined with the experiences of senior members will lead not only Tamils, but all oppressed communities towards collective liberation.

International News

05.05.2022: **US** - According to Economy Next, Fed raised interest rates by 50 basis points. Jerome Powell of the Fed has also promised to remove liquidity by selling government bonds and agency debt.

11.05.2022: **EU** - According to Economy Next, the European Union (EU) called for calm in SL. The EU calls on authorities to launch an investigation into the events and to hold those who incited or perpetrated the violence, accountable.

15.05.2022: LTTE - According to SL's Ministry of Defence, they had taken note of news published by "The Hindu" on 13.05.2022 claiming that Indian intelligence had gained information that the LTTE was planning to execute attacks in SL again, reports Virakesari.

16.05.2022: **ITJP** - According to Virakesari, the ITJP had released a report uncovering G. and M. Rajapaksa's role in the Enforced Disappearances of 1989 in a report titled, "Gotabaya Rajapaksa: The Sri Lankan President's Role in 1989 Mass Atrocities".

19.05.2022: **Britain** - According to Britain's Minister for Commonwealth and Development, Tariq Ahmed has indicated that his government is paying close attention towards the implementation of truth, justice and accountability for those killed and forcibly disappeared during the war and had indicated that they are prepared to discuss further with key stakeholders regarding a political solution inclusive of all communities, reports Virakesari.

19.05.2022: **Canada** - According to Virakesari, the Canadian Parliament had passed a resolution recognising May 18 as Tamil Genocide Remembrance Day after a motion tabled by MP Gari Anandasangaree received approval votes from 338 members of all Canadian parties. SL's Ministry of Foreign Affairs had issued a statement expressing concern over the Tamil Genocide Remembrance Day Resolution passed in Canadian Parliament and claimed that false accusations of genocide were made against SL.

21.05.2022: **Boat** - A boat travelling to Australia had been intercepted and around 15 individuals aboard the boat were detained by Australia Border Guards and detained on Christmas Island for offshore processing, reports Virakesari.

23.05.2022: **Action Plan** - According to Economy Next, the World Bank, the Asian Development Bank (ADB), and the Asian Infrastructure Investment Bank (AIIB) will work on a "joint action plan" to assist SL in their recent currency crisis. All three institutions are taking a coordinated approach to maintain basic services and livelihoods and mitigate the impact of the economic crisis on the people of SL.

24.05.2022: **Tamil Nadu -** According to the Tamil Guardian, Tamil Nadu police have arrested hundreds of people for attempting to commemorate Tamil Genocide Day. They were arrested by Tamil Nadu police.

29.05.2022: **UK** - According to the Tamil Guardian, the UK admitted to funding police training in SL while publicly condemning their attacks on protesters. Parliament Under-Secretary for the British

Foreign Office, Vicky Ford, admitted that the UK's Conflict, Stability and Security Fund (CSSF) had been used to fund police training in SL.

Bilateral Discussions

03.05.2022: **China** - According to Colombo Gazette China, has offered RMB 300 million to SL to ease their current economic crisis. With this amount, China's total amount of aid is CNY 500 million.

12.05.2022: **US** - According to Colombo Gazette, the US Ambassador to SL, Julie Chung has announced that the US is prepared to work with SL's new Prime Minister, R. Wickremesinghe.

13.05.2022: **Bilateral Talks** - According to Colombo Gazette, R. Wickremesinghe has met representatives from several countries with the intention of seeking assistance to address SL's current crisis.

14.05.2022: **Ambassadors** - Sajith Premadasa met international envoys to support SL's progression amidst criss, reports Virakesari.

19.05.2022: **US** - Karu Jayasuriya met Chung and held discussions regarding SL's current crisis on 19.05.2022, reports Virakesari. Reports indicate that Jayasuriya had suggested for discussions to be held with the leaders of comprehensive structures and policy experts to assist in addressing public grievances.

20.05.2022: **India** - According to Colombo Gazette, India has allowed SL to settle INR 1 billion of its debt.

20.05.2022: **Maldives** - Former Maldivian President and Current Speaker, Mohamed Nasheed has been appointed by R. Wickremesinghe to coordinate foreign aid and assistance for SL's recovery from its crisis, reports Virakesari.

20.05.2022: **New Zealand** - According to Virakesari, New Zealand's High Commissioner to SL, Michael Appleton and the General Secretary of the Ceylon Chamber of Commerce, Manjula de Silva occurred on 20.05.2022 to discuss future bilateral economic areas of

interest and the impact of SL's current crisis.

23.05.2022: **US** - According to Viraksari, the CWC met with Julie Chung at the US Embassy in Colombo to request assistance to face SL's economic crisis.

26.05.2022: **US** - Julie Chung met with SL's Energy Minister to discuss projects that could be conducted within SL's Energy sector to address SL's power crisis, reports Athavan News.

27.05.2022: **IMF** - According to Economy Next, the International Monetary Fund (IMF) requires SL to provide sufficient assurances to restore debt sustainability during the debt restructuring process. The IMF team held technical discussions on a comprehensive reform package to restore macroeconomic stability and debt sustainability.

27.05.2022: **US** - Julie Chung met with Mahinda Yapa Abeywardena at SL's Parliament to discuss the development of bilateral relations through the SL-Us Parliamentary Friendship Association. According to Athavan News, discussions

were also conducted regarding SL's current crisis.

28.05.2022: **India** - According to Economy Next, SL's envoy to New Delhi, Milinda Moragoda, and Finance Minister Nirmala Sitharaman are holding talks on expanding trade credit and restructuring loans already granted. The High Commissioner reiterated that SL needs bridge financing until the economic adjustment program can be negotiated and finalised with the IMF.

31.05.2022: **Britain** - R.Wickremesinghe and Britain's Prime Minister Boris Johnson had discussed British support to rebuild SL's export-oriented economy in a telephone conversation on 30.05.2022, reports Athavan News.

31.05.2022: **Saudi Arabia**- According to the Tamil Guardian, Saudi Arabia has welcomed a racist SL Buddhist monk to provide assistance to 'combat religious extremism' in SL. However, a senior representative of the Body Bala Sena (BBS), Dilantha Withanage had refuted the claim. Monk Galagodaaththe Gnanasara is known for being racist and violent.

01.05.2022:

Hambantota -

According to Economy Next, a high-level delegation from Japan's Ministry of Foreign Affairs (MOFA) visited the port of Hambantota in Sri Lanka (SL). The delegation sought "first-hand information" on a wide range of issues related to port operations and the economy.

03.05.2022: Thailand -SL Cabinet approved the purchase of cooking gas for one year through Thailand's Siam Gas Company to meet 70% of SL's gas

demand by the end of May 2022, reports Virakesari.

03.05.2022: China -According to Virakesari, China had decided to provide CNH 300 million for medicine, food, fuel and other essential commodities for SL in response to a telephone conversation between M. Rajapaksa and Chinese Premier, Li Kegiang on 22.04.2022.

04.05.2022: India -According to the Indian High Commission in SL. another 40.000 metric tonnes of

petrol is scheduled to arrive in Colombo on 04.05.2022, reports Virakesari.

04.05.2022: India -According to Virakesari, the Deputy Ambassador of the Embassy of India in Jaffna, Rakesh Natraj paid a courtesy call on the University of Jaffna on 04.05.2022 to discuss ongoing projects between the university and India.

06.05.2022: Oil -According to Economy Next, SL is in talks with Russia to import oil. However, Western nations once urged SL to be

vocal in supporting Ukraine over Russia.

06.05.2022: **EU** -According to Virakesari, the EU indicated in a published statement that they would provide EUR 200,000 which is equivalent to LKR 74 million to assist 80,000 SL families from 25 districts in light of SL's current crisis.

08.05.2022: India -India's High Commission in Colombo mentioned that claims that GoSL had imported a hydroelectric vehicle under India's Ioan scheme were false, reports Virakesari.

10.05.2022: **India** - According to Virakesari, India reaffirmed their commitment to the people of SL to completely support its democracy, stability and economic recovery in a statement issued by the media spokesperson of India's Ministry of External Affairs.

11.05.2022: **India** - According to India's High Commission in SL, speculations that India was sending troops to assist SL in crisis-management were false, reports Virakesari.

11.05.2022: **US** - The US State Department has expressed deep concern regarding violent attacks on peaceful protestors on 09.05.2022 and called on the citizens of SL to seek long-term solutions to SL's current economic and political crisis, reports Virakesari.

14.05.2022: **PM** - According to Economy Next, R. Wickremesinghe has spoken to the envoys of several countries and received a "good response" for financial assistance. However, it may take up to three months to finalise the deals.

22.05.2022: **Tamil Nadu** - According to Virakesari, a ship carrying the first batch of goods worth LKR 2 billion donated by the Tamil Nadu Government to SL arrived.

24.05.2022: Financial advisors - According to Economy Next, SL has selected French firm Lazard as financial advisor and Clifford Chance LLP as legal advisor. The advisors were recommended by a committee led by SL Finance Minister Mahinda Siriwardena and Central Bank Governor Nandalal Weerasinghe to assist SL with debt restructuring.

24.05.2022: India -According to Virakesari, SL's Cabinet had approved a loan of USD 500 million to seek cooperation with India's EXIM Bank to purchase petroleum products.

24.05.2022: **Russia** - Kanchana Wijesekara has mentioned that discussions are being held with Russia regarding the purchase of fuel to address SL's fuel crisis

with no response from Russia thus far, reports Athavan News.

23.05.2022: **Smuggling** - SL Police arrested a retired SL Army soldier, an SL Police Sergeant for smuggling 910 litres of petrol to Ampara, reports Virakesari.

23.05.2022: Navy Commander -

According to Economy Next, retired SL diplomat Aruni Wijewardane - a career Foreign Service officer has taken over as the top official in SL's Ministry of Foreign Affairs, replacing politically appointed former SL Navy Commander, Jayantha Colombage. Her appointment comes as part of a new GoSL with R. Wickremesinghe.

According to SL MP Charitha Herath, "The basic idea was to address the current economic and political crisis in Sri Lanka together or to resolve one crisis and move onto another."

03.05.2022: **Eid** - Eid was celebrated by the Muslim community in various events, reports Virakesari.

04.05.2022: **Deforestation** - According to Athavan News, a project was commenced on the illegal deforestation of the Kaluvankerni coastal area in Batticaloa where the burning of valuable trees and mangroves have been conducted for the construction of buildings. Pradeshiya Sabha member Surendran pointed out that there was a program for such activities in the area and called on local authorities to suspend such programs.

Tamil Nadu

02.05.2022 - In a media briefing after a meeting with the TNA, Annamalai mentioned that steps had been made in Jaffna to implement the 13th Amendment, reports Virakesari.

02.05.2022 - According to the Tamil Guardian, Tamil Nadu BJP leader K Annamalai visited Jaffna and met with the TNA. He tweeted: 'Humbled to have visited Nallur Kandasamy Temple to take the blessings of Lord Muruga for the prosperity of all Tamils.'

03.05.2022 - Annamalai of the BJP met representatives of NGOs in

14.05.2022: **Arrest** - Two individuals were arrested based on CCTV footage for the robbery of gold jewellery worth LKR 30 lakhs from a residence in Manipay, Jaffna, reports Virakesari.

19.05.2022: **Arrest** - According to Virakesari, eight individuals were arrested by occupational Puttalam and Karuvelachewa Police on 18.05.2022 following information received by occupational Police that they had travelled from Vavuniya to Puttalam by bus in a suspicious manner. It is notable that further investigations are underway.

19.05.2022: Arrest - Occupational SL Navy arrested nearly 40 individuals from Tamil Eelam on the morning of 19.05.2022 for allegedly boarding a boat illegally near the East Coast to seek asylum in Australia. According to Virakesari,

the arrest was made following information received by SL's Naval Intelligence Unit. Individuals from the following districts were arrested:

01.05.2022: **Drugs** - According to information received from SL's Occupational Intelligence Unit in Kilinochchi, 130 kilograms of Kerala Cannabis worth LKR 2.5 crore which was stored with the intent to be smuggled overseas was recovered during a raid in the Poonakeri Veravil area, reports Virakesari.

04.05.2022: **Cannabis** Occupational SL Navy seized 492
kilograms of Kerala Cannabis
worth LKR 123 million in Jaffna's

territorial waters and arrested a 20year-old suspect from Jaffna, reports Virakesari.

22.05.2022: **Cows** - A man was arrested for loading many cows into a vehicle without the appropriate permits in Omanthai, Vavuniya, reports Virakesari.

24.05.2022: **Cigarettes** - Occupational Kattankudy Police have arrested a 65-year-old to recover 1,020 cigarettes hidden in a residence for the trade of banned cigarettes within the area, reports Athavan News. Reports indicate that a special rais was conducted through the collaboration of the occupational Kaluwanchikudi Special Task Force and SL's Intelligence Unit.

22.05.2022: **SHARP** - According to Virakesari, SHARP had removed 33, 670 explosives from an area of 282,110 square metres in Muhamalai and Elephant Pass in Kilinochchi.

22.05.2022: **ACYF** - According to Virakesari, the All-Ceylon Youth Front had been formed under the leadership of Rasaiya Victorraj with members across Vavuniya, Mannar and Mullaitivu to call for youth seeking change to mobilise.

Fishermen

01.05.2022: **Collision** - A boat belonging to the President of the Paruththithurai Supermadam Fishermen's Association, Thevarasa Devakumar collided with a boat in waters of Vadamarachchi causing

severe damage to the boat and engine leaving it beyond repair, reports Virakesari. Reports indicate that two fishermen aboard the boat survived the crash and were brought ashore by occupational SL Navy officers.

02.05.2022: **Arrest** - According to Virakesari, occupational Indian Navy who were patrolling along the Indian Ocean border on 01.05.2022 interrogated and arrested six individuals from Trincomalee for attempting to fish in Indian borders.

12.05.2022: **Arrest** - According to Virakesari, 12 Tamil Nadu fishermen who were arrested and detained in Jaffna Prison were released from jail on 12.05.2022.

27.05.2022: **Paalamunai** - According to Athavan News, a 52-year-old fisherman from Paalamunai, Mattakalappu, has died due to a boat accident which was caused by rough seas. Due to SL's uel shortage, the fishermen were forced to go fishing in a boat without an engine. Another fisherman was also injured in this incident.

27.05.2022: **Famine** - Nallur Pradesiya Sabha Chairman, Padmanathan Mayuran had mentioned that two projects would be implemented by the Nallur Pradesiya Sabha with the intent of supporting local residents against an impending food famine, reports Athavan News.

Death

05.05.2022: **Murder** - Three individuals considered to be prime suspects in the stabbing and murder of 24-year-old Geron in Kurunakal, Jaffna on 22.08.2021 surrendered to the Jaffna Magistrate's Court on 04.05.2022

06.05.2022: **Death** - According to Virakesari, a pedestrian was killed when they were hit by the vehicle of a Puttalam District Parliamentarian on the night of 04.05.2022.

07.05.2022: **Body** - The body of 43-year-old Lalasingam was recovered from inside an lyappan temple in Kilinochchi on the morning of 07.05.2022 with further occupational police investigations underway, reports Virakesari.

14.05.2022: **Death** - According to Virakesari, the body of 29-year-old fisherman, Christopher Jacqueline who was fishing in the Mannar area had been found on the morning of 14.05.2022 when he fell into a ditch near the Mannar Railway Bridge.

19.05.2022: **Mullaitivu** - The body of 65-year-old Aiyathurai Thurairatnasingham was found hanging in the Pandiyankulam area of Mullaitivu, reports Virakesari.

30.05.2022: Relief - The Tamil Nadu Government donated relief packages to Tamils across the occupied Tamil Eelam due to the effects of SL's crisis upon their livelihood. The Indian Ambassador to Jaffna, Rakesh Natarai Jayabaskaran formally presented relief packages to local Jaffna District Agents for distribution to affected individuals. According to Athavan News, 250,000 kilograms of essential food items were also presented to the Mannar District Government Agent at the Mannar Divisional Secretariat for distribution to 25,000 families in the area. It is notable that 20,000 rice packets and 7,500 kilograms of milk powder were provided as relief packages to Jaffna locals by the Government of Tamil Nadu on 25.05.2022. 50,000 packages were also donated to Batticaloa locals. Further, 20,000 packages were presented to Kilinochchi locals on 24.05.2022.

Sri Lanka

01.05.2022: **Sri Lankan Airlines** - According to Economy Next, R. Wickremesinghe has mentioned that the SL state-owned airline, Srilankan Airlines should be sold due to its losses.

03.05.2022: **Tamil Nadu** - According to Colombo Gazette, Tamil Nadu Chief Minister, M.K. Stalin, has appealed to Tamil Nadu for donations to assist SL's crisis. His own party has donated INR 1 crore. The Tamil Nadu government is also

scheduled to send food and medicines to SL soon.

06.05.2022: **Ranaviru** - According to Virakesari, G. Rajapaksa hoisted SL's National Ranaviru Flag (Heroes' Flag) at SL's Presidential Palace to inaugurate May as Ranaviru Memorial Month which commemorates SL's brave warriors who ended over three decades of terrorism through a dedication of their lives to the independence of SL.

06.05.2022: LTTE - Whilst addressing SL Parliament, Ranil Wickremesinghe mentioned that whilst the Rajapaksas had joined with the National Leader of Tamil Eelam, Hon. V. Prabhakaran to defeat him, he had never conspired with the "LTTE Leader" at any costs, reports Virakesari.

09.05.2022: **Dematagoda & Slave Island** - According to Colombo Gazette, residents of Dematagoda and protesters have clashed as protesters were blocking the roads of Dematagoda. After several negotiations failed, the residents forcefully opened the barriers set up by the demonstrators. Two vehicles were also attacked at Slave Island by demonstrators, who were blocking the street.

10.05.2022: **Attack** - According to Tamil Guardian, Muslim shops and vehicles in Negombo were torched by individuals - allegedly on orders by a local area politician. The unidentified individuals targeted and set the shops and vehicles alight.

13.05.2022: **Pillaiyan** - According to Colombo Gazette, Pillaiyan - former

Minister and a defector from the LTTE, had fled SL. It is noteworthy that he was in jail during his election and was freed when the Rajapaksas assumed power.

15.05.2022: **SLFP** - According to Colombo Gazette, SLFP will support R. Wickremesinghe.

16.05.2022: **Pharmacy** - According to Economy Next, SL's state-owned State Pharmaceutical Corporation (SPC) is at risk of being blacklisted by foreign companies. This is because it has failed to settle imports of medicines in the last four months.

17.05.2022: **Passport** - According to Athavan News, SL's Department of Immigration and Emigration had mentioned that the process of the issuance of passports under one-day services and normal services would also be executed as usual.

17.05.2022: **Oil vessels** - According to Economy Next, SL will purchase dollars from the "free" market to pay for three oil vessels anchored in SL's waters. R. Wickremesinghe did not list what exactly the "free" market is.

18.05.2022: **Ranaviru** - Ranaviru (SL's National Veterans' Day) was upheld on 18.05.2022 by SL. In a public statement released by G. Rajapaksa on 18.05.2022 he mentioned that there was no room for racism or any other extremism in his peaceful motherland of SL, reports Virakesari.

27.05.2022: **Annual Report** - According to Economy Next, SL's listed companies are refraining from printing annual reports for the fiscal years ending 31.12.2021 and

31.03.2022 in view of SL's current paper shortage.

29.05.2022: **Reconciliation** - According to the Tamil Guardian, G.L. Peiris has mentioned that the GoSL is 'fully committed to addressing reconciliation-related issues. Reports indicate that this was mentioned during a meeting with Chung, in which he thanked the US for their support.


30.05.2022: **Farmland** - According to Economy Next, SL's newly appointed Agriculture Minister, Mahinda Amaraweera intends to propose to SL's Cabinet that all rice and farmland that has remained uncultivated for a long time would be acquired and handed over to parties willing to farm. In addition, envoys from seven countries have been

written to request fertiliser. Furthermore, talks are also taking place with Indian High Commissioner Milinda Moragoda to expedite the delivery of 65,000 tons of fertiliser from India.

30.05.2022: **Shooting** - According to Economy Next, a shooting occurred at Bastian Mawatha, Colombo. The incident occurred near a bus station when two unidentified men on a motorcycle shot at the victims as they drove by causing the death of one and the injury of another.

31.05.2022: **Arrest** - SL's Supreme Court has ordered the CID to arrest former SL Parliamentarian and murder convict, Duminda Silva, who was pardoned by G. Rajapaksa in 2021.

However, the tournament was a complete success from the point of view of the players and coaches as our young players had a lot of fun despite the outcome of the match. All our players did their best and gained a lot of experience. There is not much time left for us to prove ourselves again as there is another important tournament which is scheduled to occur in a few weeks - the Maveerar Cup in Bern. However, we will again give our best. We do not just rely on luck, but on hard work and discipline. With this strategy, we have already won.








SMALL STEPS FOR A LEAP


Internal Workshop

04.05.2022: **Debt** - According to Economy Next, SL's central bank may defer about USD 1 billion it owes the Reserve Bank of India until March 2022. This will help strengthen SL's foreign exchange reserves. India has provided the following services:

- The Reserve Bank of India provided USD 400 million to SL's Central Bank.
- On 18.04.2022, the swap was extended for another three months.
- India provided a USD 500 million loan for the purchase of fuel.
- India provided USD 1 billion for food, medicine, import of fuel and liquefied petroleum gas.

05.05.2022: **Currency crisis** - SL's Finance Minister, Ali Sabry mentioned that it could take SL up to 10 years to recover from its recent currency crisis if wrong decisions

are made. The greater the devaluation and the destruction of real capital and real income, the longer it would take, Economy Next reports.

11.05.2022: **IMF** - According to Colombo Gazette the IMF has announced that technical level discussions with SL had begun. This is a preparation for policy discussions, once a new government has been formed.

14.05.2022: **Lending** - According to Economy Next, due to the increase in interest rates, lending has slowed down. The interest rate was raised from 7.50-14.50% by SL's Central Bank Governor, Weerasinghe.

19.05.2022: **Moody's** - According to Economy Next, SL is still rated "Ca/stable"

by Moody's Investors Service rating agency after a 30-day grace period expired on 18.05.2022. The 'Ca' rating is typically associated with a recovery rate of 35-65%. Recovery assumptions for SL are due to the very low adequacy of GoSL's foreign exchange (FOREX) reserves and the very weak affordability of GoSL's debt.

20.05.2022: **Fitch** - According to Economy Next, Fitch downgrades SL to "Restricted Default" 30 days after the suspension of debt repayments announced on 12.04.2022. The dollar bonds were downgraded to "Default" (D).

24.05.2022: **Financial and legal advisors** - According to Colombo Gazette, SL has hired Lazard and Clifford as Financial and legal advisors. A creditor group of the largest holders of SL's sovereign dollar bonds had simultaneously hired Rothschild & Co. as a financial advisor and White & Case as a legal advisor.

25.05.2022: **Payments** - According to Economy Next, SL plans to save USD 2.3 billion in foreign loans over the next six months to pay external creditors. However, USD 900 million must be paid to multilateral organisations.

27.05.2022: **Fitch** - Fitch Ratings has downgraded Singer Finance and placed four other financial firms on a negative rating due to a rise in interest rates, which has caused the LKR to fall, Economy Next reported.

27.05.2022: **Standard & Poor's** - Rating agency Standard and Poor's has downgraded two SL government bonds maturing in 2025 and 2027 to "default"

(D). Fitch had previously downgraded SL's sovereign bonds to 'D' due to cross-default clauses after payments were not made, Economy Next reported.


30.05.2022: **Garment** - According to the Tamil Guardian, women in Sri Lanka's textiles and garments industry are having to turn to sex work as the economic crisis worsens.

31.05.2022: **Tax** - According to Economy Next, SL will raise taxes back to 2019 levels. The Cabinet has approved amendments to the following tax laws to raise revenue. The Law on the Responsibility of the Tax Administration will also be amended.

05.05.2022: **Walk** - A family of fathers from Nuwara Eliya commenced a 178 kilometre walk from Dayagama Chandrikamam Estate from the morning of 05.05.2022 to strengthen the Colombo protests through their participation, reports Virakesari.

06.05.2022: **Protest** - According to Colombo Gazette, protesters have put up their underwear on barricades around Parliament Road. Also the Hiru Go Gama protest camp that was established at the Parliamentary Road was attacked by SL Police with water

cannons and tear gas as students had down a barrier.

06.05.2022: **Protest** - A demonstration was staged in Vavuniya by SL's People's Health Services Union against GoSL and severe medical supply shortages, reports Virakesari.

06.05.2022: **Protest** - According to Virakesari, a mass anti-GoSL protest was staged in the Iragalai city of Nuwara Eliya with the participation of thousands including plantation workers from over 10 estates.

06.05.2022: Clash - 16 individuals were hospitalised to Akkaraipattu Base Hospital for treatment following clashes between occupational SL Police and civilians at a police roadblock around 23.30 local time on 05.05.2022, reports Virakesari. It is notable that Akkaraipattu's Police Chief was also hospitalised in the incident.

resignation. Police used tear gas and water cannons to disperse the crowd.

10.05.2022: Attack -The Temple Trees. was besieged by thousands of protesters on the night of 09.05.2022 and vehicles bringing supporters were set on fire and plunged into a nearby lake. There were 8 people killed and over 100 houses damaged or set on fire, Economy Next reported.

10.05.2022: **Protest** - According to Economy Next, overnight violence in SL left at least 5 people dead across the country and 219 people hospitalised. Three individuals died in an incident in Nittambuwa.

10.05.2022: **Protesters** - According to Economy Next, small groups of protesters attacked senior SL Police officer Deshabandu Tennakoon. The crowd wanted to know who had ordered an attack on peaceful government opponents, as the answer was not satisfactory, they attacked.

According to Economy Next, unions in SL have called off a continuous strike. It was the responsibility of the unions to help stabilise SL after the violence.

13.05.2022: Protest -Masses blocked the Negombo Road calling for the provision of cooking gas, reports Virakesari. Further reports indicate that the block caused traffic congestion in the Mahabage area on Colombo-Negombo Road.

13.05.2022: **Violence**- SL's CID launched an investigation into the violence which occurred near the Temple Trees and have thus announced hotlines that the public could contact to report property damage, injuries or attacks, reports Virakesari.

14.05.2022: Protest -Residents of Gunasingapura blocked roads on 14.05.2022 to protest against a lack of gas supply despite having waited. According to Virakesari, the protestors were dispersed following assurances provided by an SL Military officer that gas would be distributed.

14.05.2022: Arrests -Four individuals were arrested in relation to the arson attacks launched on the houses of key SL politicians, reports Virakesari. Nawalapitiya Police arrested four of sixteen suspects and produced them before the Nawalapitiya Magistrate who permitted them to be released with a personal bail of LKR 1 lakh.

He mentioned that he had commenced his journey to seek justice for the forcibly disappeared and to support the struggle over SL's economic crisis.

20.05.2022: **Protest** - According to Virakesari, Vavuniya locals blocked the A9 demanding gas causing traffic to come to a halt for around 30 mins. Consequently, occupational police and army officers were deployed to the site resulting in

brief tensions between the public and the officers.

20.05.2022: **Protest** - Nuwara Eliya General Hospital's medical staff staged a protest against SL's G. Rajapaksa administration in solidarity with mass anti-GoSL protests, reports Virakesari.

22.05.2022: **Fuel** - According to Virakesari, occupational Army presence at a petrol station in Arayampathi due to high mass tensions due to a refusal to distribute petrol to the public despite fuel availability.

22.05.2022: Arrest - According to Virakesari, SL's CID had arrested 225 individuals in connection with inciting violence through social media networks for further investigations.

22.05.2022: Inquiry - According to Virakesari, SL's CID had conducted a special inquiry into SL's Inspector General of Police, Chandana Wickramaratne on 21.05.2022 as a part of wider investigations.

22 05 2022: Fire -According to Economy Next, the house of a petrol station owner and dealer in Anuradhapura was set on fire by an unidentifiable mob on the night of 21.05.2022. At the time of the incident, the station dealer. his wife and two children were in the house, however, none were injured. The motive for the arson attack has not yet been determined.

22.05.2022: Court -According to Virakesari, Major General Jagath Alwis, SL's Secretary of the Ministry of Law and Order had been accused of contempt of court for alleaedly sendina a letter to SL's Chief of Justice focussing on the refusal of SL Courts to issue a restraining order to ban mass protests.

24.05.2022: **Protest** - A protest had been staged opposite SL's CID Department demanding the arrest of Johnston Fernando as confessions are being obtained from him through SL's CID investigations, reports Virakesari.

25.05.2022:

Chemical Analysis -According to Virakesari. Colombo's Additional Magistrate, Manjula Ratnayake had issued a special order on 24.05.2022 to obtain the State Chemical Analysis Report on the arson of vehicles during violence unleashed in Colombo following the incidents of 09.05.2022.

25.05.2022: **Arrests** - According to Economy Next, SL police arrested

another 117 people in connection with Black Monday attacks. SL Police Spokesman, Nihal Thalduwa mentioned that SL Police have arrested 1,708 suspects in connection with 852 reported mob attacks across SL thus far.

25.05.2022: **Protest** - A protest was staged opposite the Fort Magistrate's Court against SL's Senior Deputy Inspector General of Police, Deshabandhu Tennakoon, reports Athavan News.

26.05.2022: **Protest Square** - According to Economy Next, only four young men were at the entrance of SL's Presidential Secretariat after the appointment of R. Wickremesinghe. The protest site near SL's Presidential Secretariat opposite Galle Face was thus almost empty.

26.05.2022: **Vigil** - A candlelight vigil is scheduled to occur at Independence Square from 10.00 local time on 28.05.2022 near the Bandaranaike Statue to mark the 50th day of the Gota Go Home protests,

reports Athavan News.

26.05.2022: Meeting -According to SL's Prime Minister's Office, a program has been launched via their official website to allow youth and groups involved in Gota Go protests to submit issues and sugaestions to implement change, reports Athavan News. Reports indicate that there may be opportunities for such youth to meet R.Wickremesinghe to develop more effective and practical plans to address SL's crisis.

27.05.2022:

Demonstration -According to Economy Next, hundreds of antigovernment protesters in SL gathered opposite Wickremesinahe's office in Colombo, to demand justice for the Black Monday attacks. Furthermore, they demand immediate action to overcome SL's ongoing economic crisis to prevent imminent social unrest.

27.05.2022: **Arrests** - According to Economy Next, four individuals

Permanent People's Tribunal III

People's Tribunals are a form of grassroots justice and take the form of opinion tribunals organised by civil society. The panel of judges is largely made up of relevant prominent members of society like past judges or intellectuals. People's Tribunals have a long tradition and are usually organised for issues where governments failed to provide justice. Most People's Tribunals are organised to hold states accountable for violations of international law by building public awareness and generating a legitimate evidence record. People's Tribunals can also play an important role in empowering victims and recording their stories.

I was fortunate enough to attend the Permanent People's Tribunal 3 on behalf of Phoenix TNG - the third in a series of tribunals held considering the Tamil genocide perpetrated by the Sri Lankan State, held in Central Berlin in May 2022. It was an honour as previous work compiled by the tribunals have provided ample material to further work as a young Tamil Eelam liberation activist in the past. This tribunal had considered niche but extremely important questions such as the complicity of a superpower and other prominent state actors in engineering the conditions for genocide. I say "niche" as the question posed is not to do with monetary aid or supply by way of arms and technical equipment to enable Mullivaikal, but rather was the stage leading to 2009 set, meticulously, through the sustained efforts of powers outside the island. It is a stage that helped the Sri Lankan State to achieve its crown jewel in its several decades-long

genocide efforts against the Tamil nation - a genocide that is still ongoing. However, Mullivaikal allowed accelerated structural genocide currently experienced without any buffers and has incinerated six per cent of Tamil Eelam's total population.

This Tribunal is an alternative space for justice. Tying heart-wrenching, many insightful testimonies from first-hand witnesses from Mullivaikal, some for which audience participation was disallowed due to witness safety concerns, and beyond to pass judgement on critical questions. Furthermore, depositions from experts who have tirelessly held firm in our struggle towards self-determination supported the case were put forward. The most surprising was that many people showed solidarity and accurate knowledge of the Tamil genocide, from people in Colombia to Kashmir to Jeju Islands to Okinawa. A commendable group of tireless organisers and a panel of judges includes indigenous people with lived experience of oppression, professors to ex-supreme court judges. From all over the world, the message is clear - our Tamil Eelam state is an endless measure of resistance and inspiration for the oppressed. People all over the world want Tamil Eelam - the structures of yesteryear will crumble.

PPT supports a pillar in Phoenix's core principles which is the creation of new and retrieving lost, independent Tamil spaces - both civil and political. Reclaiming such spaces is an effort for said spaces to be a steppingstone towards self-determination. Defining a narrative is important and freedom to do so becomes difficult for oppressed people - especially people who have been and who are currently on the receiving end of calculated and prolonged genocide - a prime example, is the Tamil people.

Furthermore, initiatives such as PPT serve to play a crucial role in creating solidarity with known and unknown oppressed people all over the world. Learning from people who have historically or at present experienced the trauma of events like that of the Tamil nation is crucial in seeking justice and a permanent solution without relinquishing our autonomy as an indigenous people of Tamil Eelam.

On a personal level, it was therapeutic - the love of indigenous people from across the world was not only healing but motivating. Motivating, because many indigenous people battling oppression by force or litigation against state or MNCs took incredible inspiration and expressed voluntary willingness to learn more about the pinnacle of Tamil collective achievements in modern history - the state of Tamil Eelam.

02.05.2022: **Removal** - The Batticaloa Magistrate's Court ordered all students of the Swami Vibulandanda Institute of Aesthetic Studies of Batticaloa East University to leave the hostel premises from 02.05.2022 under Section 106(1) of SL's Criminal Procedure Code No.15 (1979), reports Virakesari.

04.05.2022: **PTA** - The Eravur Tourism Court ordered the remand of Batticaloa Tamil

Awareness Organisation leader, Ganavathipillai Mohan under the PTA until 11.05.2022 based on allegations that he had uploaded images of the LTTE to websites, reports Virakesari.

04.05.2022: **Easter Sunday** - According to Virakesari, Batticaloa's Magistrate Court Judge, Peter Paul ordered that the 55 individuals arrested and kept in detention to be further detained until 17.05.2022 to extend interrogations into the investigation of their role in 2019's Easter Sunday Attacks.

04.05.2022: **Commemoration** - According to Virakesari, tributes were made to 75-year-old Sellaya Selvarani who was searching for her son, son-in-law and grandson who were forcibly disappeared in Vavuniya had recently died due to illnesses. It is notable that the mother had been engaged in the protests conducted by the families of the disappeared and thus the families staged a vigil for her in Vavuniya.

05.05.2022: **Shooting** - According to Athavan News, 16 individuals have been injured in a clash between occupational SL police and civilians on duty at an SL police checkpoint opposite Palamunai Hospital, Ampara District. 11 policemen, including a journalist and 4 civilians were injured in the incident and were admitted to Akkaraipattu Base Hospital for treatment dye to open fire by occupational Amparai police.

10.05.2022: **Attack** - Occupational Kilinochchi Police attacked a pregnant

woman and differently abled individuals in indiscriminate attacks within the Ramanathapuram region, causing backlash from locals, reports Virakesari.

12.05.2022: **Protest** - According to Virakesari, a protest had been launched on 12.05.2022 against the attack of a garment factory in Eravur, demanding the arrest of the attackers.

12.05.2022: **Commemoration** - A vigil was held at the reconstructed Tamil Genocide Memorial Monument at Jaffna University Campus by university students and staff, reports Virakesari.

12.05.2022: **Commemoration** - An awareness campaign with displays portraying a timeline of acts of Tamil genocide was put on display near the remains of Lt. Col. Thileepan's desecrated monument in Nallur, Jaffna in light of Tamil Genocide Week, reports Virakesari.

12.05.2022: Mullivaikkal Remembrance - According to the Tamil Guardian, occupational SL Police threatened to shoot Tamils who were gathering in Mullaitivu to commemorate Tamil Genocide Day. They mentioned that: 'We remind you we have a shooting order as well!' Meanwhile, a flame was lit at Nandhikadal lagoon.

13.05.2022: **Commemoration** - The second day of Tamil Genocide Week was commemorated by the TNPF in Jaffna where a lamp was lit and respects were made near Semmani around 11.00 local time, reports Virakesari.

13.05.2022: **Commemoration** - Tamil Genocide Week was commenced with the lighting of a lamp at Nandhikadal. According to Virakesari, Peter llancheliyan commenced commemorations by lighting a public flame and laying flowers in the area.

13.05.2022: **Commemoration** - Kanji was served across the Tamil homeland in light of Tamil Genocide Memorial Week. According to Virakesari, leaflets titled, "Mullivaikkal Kanji" were also distributed to the public.

14.05.2022: **Seminar** - The Tamil Nadu Students' Federation organised a commemorative Mullivaikkal Genocide Commemoration Seminar with mass attendance and participation by Tamil Nadu BJP leader, Annamalai and former Tamil politician, M.K. Sivajilingam, reports Virakesari.

15.05.2022: **Commemoration** - The 37th Memorial of the Kumuthini Boat Massacre was held in Neduntivu, Jaffna, reports Virakesari.

15.05.2022: LTTE - According to Colombo Gazette, SL's Defence Ministry sought details from India about an alleged planned attack by the LTTE. This allegation was based on an article from The Hindu which was published on 13.05.2022 which claimed that the LTTE was to conduct an attack on 18.05.2022.

"After inquiring about the above information, the Indian intelligence services have informed Sri Lanka that the information has been given as general information and further informed that the investigations will be carried out in this regard and action will be taken to inform Sri Lanka about it."

Organisation, reports Virakesari. Kanji was also served at Kilinochchi Vaddakkachchi Public Market and Valvettithurai Muthumari Amman Temple, Jaffna.

16.05.2022: **Commemoration** - The Mullivaikkal Commemoration Awareness Float reached Mannar, reports Virakesari.

16.05.2022: **Commemoration** - A rally which commenced from Valvettithurai Jaffna reached the Tamil Genocide Monument at Jaffna University on 16.05.2022 where it is notable that Sinhala students had also participated in commemorative practices, reports Virakesari. It is notable that floral tributes were made, lamps were lit and Mullivaikkal kanji was served at the event.

17.05.2022: **Disappearances** - In a published statement, the Families of the Disappeared (FoD) requested SL Parliamentarians to publish the names of alleged perpetrators who examined the JVP Uprising, reports ITJP.

17.05.2022: **Commemoration** - Peter Ilancheliyan marked the 6th day of Mullivaikkal Commemoration Week by lighting a public flame at Pudhukudiyiriuppu Madu Junction in memory of massacred civilians, reports Virakesari.

17.05.2022: **Commemoration** - Mullivaikkal porridge was served by the Tamil National Green Movement in Jaffna on 17.05.2022 from 09.00 local time opposite the organisation's office in

Kantarmadam, Jaffna, reports Virakesari.

17.05.2022: **Commemoration** - According to Virakesari, a Tamil Genocide Commemoration event was held at the Tamil Genocide Monument at Jaffna University Campus on 17.05.2022 with mass student participation.

17.05.2022: **Float** - A Mullivaikkal Awareness Float organised by TNPF commenced its journey from Kilinochchi at Depot Junction opposite an SL Victory monument where a lamp was lit and floral tributes were made to the commemorative monument aboard the float, reports Virakesari. It is notable that the vehicle is to travel towards Mullivaikkal for commemorations on 18.05.2022.

17.05.2022: **Surveillance** - The Tamil Genocide Commemoration Awareness float organised by the TNPF was closely followed by a three-wheeler containing uniformed individuals and later were followed by two individuals in plain clothes who were travelling on motorcycles and taking photos, reports Virakesari.

18.05.2022: **Commemoration** - Tamil Genocide Day was observed by the TNA opposite Kalladi Siddhivinayagar Temple in Batticaloa where kanji was served and tributes were made, reports Virakesari.

18.05.2022: **Commemoration** - According to Virakesari, the Valikaamam East Pradesiya Sabha held a commemoration event in light of Tamil Genocide Day where a lamp was lit.

18.05.2022: **Commemoration** - Floral tributes were made at Nandhikadal by Durairasa Ravikaran on 18.05.2022 in memory of the lives lost at Mullivaikkal, reports Virakesari.

18.05.2022: **Commemoration** - According to Virakesari, Tamil Genocide Day was held at the Equality Party Office in Kilinochchi where lamps were lit, floral tributes were made, and silence was observed.

18.05.2022: **Commemoration** - According to Virakesari, Tamil Genocide Day commemorations were held across various locations in Jaffna including sites of worship.

18.05.2022: **Commemoration** - Tiruch Chepamalai was held in Bhavani Mannar in commemoration of Tamil Genocide Day, reports Virakesari.

18.05.2022: **Commemoration** - The first Mullivaikkal commemoration was coorganised by Tamils and Sinhalese in Colombo to commemorate "the victims of war", reports Virakesari. Further reports indicate that members of the Buddhist and Christian clergy were present at the memorial service where flower tributes were made at sea, a commemorative monument was erected and Mullivaikkal Kanji was served at Galle Face.

18.05.2022: **Commemoration** - According to Virakesari, a Tamil Genocide Day commemoration event was held from 08.00 local time in Mannar as organised by V.S. Sivakaran.

18.05.2022: **Commemoration** - Tamil Genocide Day commemorations were held by the Relatives of the Disappeared Association - Vavuniya who were conducted their awareness protest demanding justice for their enforcibly disappeared relatives for over 1,915 days, reports Virakesari.

18.05.2022: **Commemoration** - According to Virakesari, TNA officials held a minute's silence in SL Parliament during which an SL Leading Party member intervened and mentioned that whilst they do not understand the language in once a moments' silence was held, they had commemorated the LTTE who had died at Nandhikadal and thus requested SL's Speaker to remove such commemoration from SL's Hansard. Reports indicate that the request was made on the basis that the LTTE could not be commemorated whilst SL paid respects to their war heroes - the genocidal SL Army who died during the war.

21.05.2022: **Genocide Motion** - The Valikaamam West Pradesiya Sabha has passed a resolution that a planned genocide was conducted against Tamils, reports Athavan News. Reports indicate that the resolution was passed with the support of most of the members who were present at the Pradesiya Sabha's Session which was held on 20.05.2022. It is notable that members of the EPDP and SLFP had left the session as the discussion ensued.

22.05.2022: **Assault -** According to the Tamil Guardian, a Tamil man was hospitalised after being assaulted by SL military-aligned thugs. Vivekanandan

Piriyangan, who resides in Mullaitivu, was attacked for commemorating Tamil Genocide.

25.05.2022: **OL** - According to the Batti Press Club, students from the Batticaloa Education Zone have been prevented from receiving admission cards to appear for their Ordinary Level Examinations by SL, thus violating their fundamental rights to education, reports Athavan News.

30.05.2022: **Book** - According to the Tamil Guardian, a book has been launched to mark the 18th memorial of Tamik journalist, Aiyathurai Nadesan's assassination. Tamil Press Clubs in the Tamil Homeland launched the book, which is a compilation of essays written by Nadesan's friends and family from Jaffna and Batticaloa.

30.05.2022: **Missing** - According to occupational Kalmunai Police, 16-year-old girl, Wadurdeen Fatima Sajana had been missing since 14.30 local time on 29.05.2022, reports Athavan News.

30.05.2022: **Enforced Disappearances** - According to Athavan News, the relatives of the forcibly disappeared have staged several protests across the homeland. One such protest was staged in Mannar opposite the old bus station, and another occurred in Kilinochchi. It is noteworthy that 115 relatives of the disappeared have already died whilst searching and protesting for their relatives.

31.05.2022: **Dead** - According to Athavan News, a missing 16-year-old girl was found dead in the Kanasapuram Forest

in Vavuniya. The girl went missing one day earlier. It's noteworthy that a 9-yearold girl named Fatima Aisha was found dead in Atulugama on the 27th. 31.05.2022: **Commemoration** - The 41st memorial of the burning of the Jaffna Library was commemorated across the Tamil homeland.

Signs of Structural Genocide

20.05.2022: **Buddhicisation** - A Donation Event for the maintenance of the Naga Viharai was conducted in Jaffna to mark Vesak, reports Athavan News. Donations were made by public organisations. The Naga Viharai is located in Jaffna and was attacked by locals in the past as the site was used to appropriate neighbouring Tamil areas. The financial strengthening of the site heightens Buddhicisation attempts which disrupt the Tamils' territorial integrity thus furthering Tamil genocidal ideology.

21.05.2022: Land appropriation -

According to Athavan News, attempts to survey land in the Kodikaamam area for the establishment of an occupational Army Camp have been interjected and prevented by locals. Troops of the 15th Gajabahu Regiment have been reported to be camping on 10.5 acres of privately-owned land to acquire the lands - an attempt which was suspended by local intervention and opposition.
